Who looks after your personal information

How we use your personal information

We will use your personal information:

- to provide products and services, manage your relationship with us and comply with any laws or regulations we are subject to (for example the laws that prevent financial crime or the regulatory requirements governing the products we offer).
- for other purposes including improving our services, exercising our rights in relation to agreements and contracts and identifying products and services that may be of interest.

To support us with the above we analyse information we know about you and how you use our products and services, including some automated decision making. You can find out more about how we do this, and in what circumstances you can ask us to stop, in our full privacy notice.

Who we share your personal information with

Your personal information will be shared within Lloyds Banking Group and other companies that provide services to you or us, so that we and any other companies in our Group can look after your relationship with us. By sharing this information it enables us to better understand our customers' needs, run accounts and policies, and provide products and services efficiently. This processing may include activities which take place outside of the European Economic Area. If this is the case we will ensure appropriate safeguards are in place to protect your personal information. Where we collect your personal information from

We will collect personal information about you from a number of sources including:

- information given to us on application forms, when you talk to us in branch, over the phone or through the device you use and when new services are requested.
- from analysis of how you operate our products and services, including the frequency, nature, location, origin and recipients of any payments.
- from or through other organisations (for example card associations, credit reference agencies, insurance companies, retailers, comparison websites, social media and fraud prevention agencies).
- in certain circumstances we may also use information about health or criminal convictions but we will only do this where allowed by law or if you give us your consent.

Do you have to give us your personal information

We may be required by law, or as a consequence of any contractual relationship we have, to collect certain personal information. Failure to provide this information may prevent or delay us fulfilling these obligations or performing services.

What rights you have over your personal information

The law gives you a number of rights in relation to your personal information including:

- the right to access the personal information we have about you. This includes information from application forms, statements, correspondence and call recordings.
- the right to get us to correct personal information that is wrong or incomplete.
- in certain circumstances, the right to ask us to stop using or delete your personal information.
- the right to receive any personal information we have collected from you in an easily re-usable format when it's processed on certain grounds, such as consent or for contractual reasons. You can also ask us to pass this information on to another organisation.

Other Individuals you have financial links with

We may also collect personal information about other individuals who you have a financial link with. How we use credit reference agencies

In order to process your application we may supply your personal information to credit reference agencies (CRAs) including how you use our products and services and they will give us information about you, such as about your financial history. We do this to assess creditworthiness and product suitability, check your identity, manage your account, trace and recover debts and prevent criminal activity.

We may also continue to exchange information about you with CRAs on an ongoing basis, including about your settled accounts and any debts not fully repaid on time, information on funds going into the account, the balance on the account and, if you borrow, details of your repayments or whether you repay in full and on time. CRAs will share your information with other organisations, for example other organisations you ask to provide you with products and services. Your data will also be linked to the data of any joint applicants or other financial associates as explained above.

How we use fraud prevention agencies

To make sure that your Embedded Payment Solution accounts benefit from enhanced security between you and your suppliers, you need to opt for one of the three card payment account restrictions outlined below.

In this section we introduce these three options to enable you to select the right restriction for your type of payments. These restrictions are necessary to make sure we align with regulatory requirements. If you have not activated your selected restriction within 90 days, we'll reach out to discuss next steps.

Restrictions will only apply to transactions on your selected card payment account once they have been activated. Up to that point transactions will be processed without verifying against any of these specific restrictions.

Option 1: Merchant IDs (MIDs)

MIDs are unique identification numbers allocated to a merchant by their acquirer. There could also be multiple MIDs that represent the different ways in which a business can process a card payment.

The MID restriction will only allow transactions to take place with registered MIDs. You can select a maximum of 10 MIDs per card payment account.

Please be aware a MID can change, and this typically happens when a supplier changes their merchant services provider. If a MID changes which has not been registered, this will produce a decline. Please refer to the 'Supplier Merchant IDs' section below for further information.

You'll need to perform a transaction with your supplier to activate this option. See the instructions below on how to do this.

Recommendation: Use this option to restrict each card payment account to a maximum of 10 Merchant IDs and benefit from the greatest level of enhanced security.

Option 2: Merchant Category Codes (MCCs)

MCCs are standard codes used by the payment processing industry. An MCC is a four-digit number that classifies the specific type of goods or services a business offers. You can select up to two MCCs per card payment account. Transactions are restricted to suppliers within the selected codes.

You'll need to perform a transaction with your supplier to activate this option. See the instructions below on how to do this.

If you need access to a wider selection of suppliers, you can select this option to restrict your card payment account to a maximum of two Merchant Category Codes (MCCs). This will restrict spend to those specific merchant categories and will also provide enhanced security.

Depending on the categories you select, payments could be permitted to a significantly wider group of merchants.

Option 3: Merchant Category Groups (MCGs) - Travel Payments

MCGs group individual Merchant Category Codes to create a broader industry classification for the type of goods or services a business offers.

Please note this option is only available for bookable travel payments. A single card payment account can be restricted to either or both of the following Merchant Category Groups: 0027 Travel Air/Rail/Road and 0029 Hotels and Accommodation. Please contact Corporate Card Services to activate these two travel MCG restrictions.

If you select these two travels MCGs on this application form to be restricted, then these restrictions will be activated and won't need any further action.

How to activate your card payment account with your supplier for options 1 or 2

You start the process collating your MIDs or MCCs by performing a transaction.

Step 1 Provide each supplier with the 16-digit card payment account number, expiry date, CVV number (3-digit code), and the account name.

You must do this using a secure method. For example, secure hosting with supplier log-on, or separating the card payment account details across different communication channels such as, encrypted email and phone. This is to avoid disclosing the card details on one single form of communication.

Your supplier should then register your card payment account details with their Payment Services Provider under an encrypted name or reference number. This will allow your supplier to process transactions without having to re-enter your card payment account details again in future.

- Step 2 Supplier carries out a transaction using all purchase order channels with your card payment account. This will make sure that you capture all supplier MIDs or MCCs.
- Step 3 Supplier notifies you that all MIDs or MCCs have been transacted on to complete the set-up process.
- Step 4 Contact Corporate Card Services to register your selected supplier MIDs or MCCs with your card payment accounts for activation. Your welcome email and letter will provide you with further instructions on how to complete this process.

Activated MIDs or MCCs will make sure that transactions are only authorised for suppliers that hold one of your selected MIDs or MCCs.

Supplier Merchant IDs

What do you do if Merchant IDs or Merchant Category Codes change

If your supplier has made you aware that a MID or MCC will change, you can contact Corporate Card Services to deactivate your existing restriction. Transactions will then be processed without verifying against your specific restriction.

Any new MID or MCC needs to be registered by completing the following steps:

Step 1 Perform a transaction with each new supplier MID or MCC so that they can be collated.

Step 2 Contact Corporate Card Services to register the new MID or MCC to complete the activation process.

If your preferred restriction is deactivated, you'll need to make sure that your new MIDs or MCCs are activated within 30 days.

Alternatively, if your existing restrictions have produced a decline, you can contact us to register and activate these new MIDs or MCCs.

for Cardholders and Programme Administrators of all Corporate Card products, and users of the Embedded Payment Solution (EPS) or any Corporate Card online solutions, including CCIS and CCDM.

Conditions of Use - how to use your Corporate Card products

Things you must do

- 1. Only use the payment devices and online solutions that we give you access to for authorised business purposes (your business will tell you what this covers).
- 2. Tell us if you change your name, address or other information you have given us.
- 3. Keep safe your PIN, security details and any information you have about cards, payment devices and online solutions. Do not give them to anyone, including our staff. They must be kept secret and, if you write them down, they must not be recognisable or kept with cards, Business Travel Solution (BTS) or Embedded Payment Solution (EPS) details, or details about cards. PIN numbers and security details must not be easy for someone else to guess. They should be changed if we recommend this or if you suspect someone else might know them.
- 4. Stay within the limit of your payment device.
- 5. Tell us immediately if (a) any payment device is lost or stolen; (b) you think someone else knows any security details, including for online solutions; or (c) any payment device or online solutions might have been misused.
- 6. Check any cardholder statements as soon as possible when you receive them, preferably within 30 days. Tell us straight away if an entry seems wrong. Co-operate with us and the police if we need to involve them.
- Take reasonable steps to protect the systems and equipment behind our online solutions from viruses and other intrusive devices, including by making sure your equipment is compatible and virus free.
- 8. Stop using the payment devices and online solutions immediately if you stop being an employee, contractor or agent of the business for any reason. If applicable, you must give them to the business.

Things you must not do

- 1. Let third parties, including our staff, use payment devices or access our online solutions.
- 2. Misuse any online solutions you have access to. You must respect the intellectual property rights in these solutions, which belong to us and others. You do not have any rights in our online solutions except the access rights we give you. You must not make changes to our online solutions or create any links to or from a website to them. You must not use our online solutions in countries where doing so is unlawful.

We may make changes to these Conditions of Use for any reason at any time. If the Conditions of Use change, we will tell Programme Administrators, and Programme Administrators will tell cardholders and users.

Frequently Asked Questions

What must I do first?

You must sign any plastic card. You also need to activate plastic cards, BTS details and EPS in the way we tell you when we give you them.

What is my card or spending limit?

Your Programme Administrator will tell you this and also whether or not there are restrictions on what you can do with the card, BTS details or when using EPS.

Can I get cash?

Your Programme Administrator can tell you this.

Can I change my PIN?

You can change your PIN at any of our ATMs. Try not to choose a PIN that is easy for someone else to guess.

How must I use my card, BTS details or EPS?

You must follow the instructions provided by the supplier you are buying from. You can normally make payments by:

- · Chip and Pin
- Contactless
- signing a sale voucher
- adding BTS details to a travel booking site
- embedding and using EPS with a supplier.

What must I do if my payment device is lost or stolen or is being misused, or if someone finds out any of my security details, including for online solutions?

Tell us by calling us on 0800 096 4496 (24 hours if it's about a lost or stolen payment device and Monday to Friday 8am–8pm, Saturday 9am–4pm if it's about fraud). If abroad, call +44 1908 544059.

Why would my transaction be declined?

It might be declined because (a) you have already reached your card or spending limit; (b) you are restricted by your business from making the transaction; (c) to protect your business from fraud or security concerns; (d) a regulatory requirement means we have to decline the transaction; or (e) we are owed money by your business.

It might also be declined because your payment device has been suspended or cancelled and this could be for the above reasons too. As soon as we can, we'll tell the business that we are going to stop or have stopped the use of a payment device and why, unless the law says we can't or it would undermine our security measures. We won't stop it for longer than we need to. We'll let it be used again or provide a new one as soon as possible.

What can I do if my transaction is declined?

Can I cancel a transaction?

What transactions can you cancel?	Transactions scheduled for a future date. A series of recurring transactions. You cannot cancel other transactions once you have authorised them.
What you must do to cancel	 Tell us by the end of the day (8pm Mon–Fri, 4.30pm Sat) before the day the transaction is due to be made. Tell the supplier you have asked us to cancel the transaction. If you also want to cancel your agreement with them, you will need to do that directly with the supplier.
What will happen	 We will not carry out a transaction once you have cancelled it in this way. Unless you tell us otherwise, we will treat cancellation of recurring transactions as cancelling all future transactions in the series.

Who pays for my transactions?

Your business is responsible for payment.

What must I do if I have a problem with a transaction?

If you see a transaction you don't recognise, contact us without delay on 0800 096 4496 (24 hours if it's about a lost or stolen payment device, but Monday to Friday 8am-8pm, Saturday 9am-4pm if it's about fraud.) If abroad, call +44 1908 544059.

If you have a different problem or a question about a transaction, for example about the goods or service paid for, you should contact the relevant supplier.

Is there a charge for using the online solutions?

We will not charge you for using our online solutions. Your mobile operator may charge you for using certain services such as downloading or using our online solutions on your devices
