### Lloyds Bank plc Canadian Notices

Lloyds Bank plc relies upon the following exemptions with respect to Canadian dealer registration requirements (the “**Canadian Registration Exemptions**”):

- The International Dealer Exemption (“**IDE**”) pursuant to s. 8.18(2) of National Instrument 31-103 Registration Requirements, Exemptions and Ongoing Registrant Obligations (“**NI 31-103**”); and
- The Foreign Derivatives Dealer Exemption (“**FDDE**”) pursuant to s. 39 of Multilateral Instrument 93-101 Derivatives: Business Conduct (“**MI 93-101**”).

Please note that if you are a client domiciled in Canada, when Lloyds Bank plc trades with you it does so in reliance upon the Canadian Registration Exemptions (as such Canadian Registration Exemptions may be amended and restated from time to time). Please also note that in connection with the disclosure requirements contained within s. 8.18(4) of NI 31-103 and s. 39(2) of MI 93-101:

1. Lloyds Bank plc is not registered as a dealer or derivatives dealer in any Canadian province or territory;
