

Win £1000 to spend on latest Apple products prize draw – Terms & Conditions

1. This Prize Draw (the "Draw") is open to Lloyds personal customers who hold any product with the promoter, e.g. mortgage, credit card or a personal current account product and are UK resident and 18 +.
2. The Draw opens on 1st August 2026 and will close at 23:59 on 31st August 2026. Entries received after the closing date will not qualify.
3. Simply activate the 'Win £1000 to spend on the latest Apple products' prize draw in Lloyds Rewards app before the closing date to enter.

There is no purchase necessary to enter.

One entry only and you can only win one prize. This applies even if you have more than one product with the Promoter.

4. Joint account parties can enter the Draw but must activate the Draw individually.
5. There are 25 Lloyds Apple Store Prize Redemption Code prizes of £1000 to be won.

The Prize Redemption Code can only be used within Lloyds Rewards, on Apple Products

There is no cash alternative.

The Prize Redemption Code will expire 13 months from the date of issue.

Use of Prize

The £1,000 Apple Prize Redemption Code must be redeemed in full via the 'Lloyds Rewards app' store for Apple products, in a single transaction. No credit, refund, or alternative will be provided for any unused portion of the voucher code, and any remaining balance will be forfeited at the point of use.

If a winning customer redeems the Prize Redemption Code against a purchase totalling £600, the remaining £400 balance will be lost and cannot be used in any subsequent transactions.

A reserve list will also be selected if any of the winners are not eligible to claim the prize.
